Cathy - Town has received the additional funds from (FEMA) for the change in amount that FEMA was reimbursing for Hurricane storm damage. Change was from 75% of cost to 90% of cost. The State will also reimburse its portion at some point as well.

Kevin - Scheduling roadside mowing, chloride as needed.

Earl - received response from Town's Attorney ready to advise in reclassify town roads process.

Also - State rte. 109 is scheduled to be repaved in next yr or two, through Belvidere. Once the contract has been awarded should the town reach out to hired contractor for possible areas in town as they will already be in town. will contact Jim Cota (VTRANS) for assistance.

Ken - researched town highways budget to date approximately half is still available
