#### What else has been undertaken:

- Belvidere SB has researched possible use ideas discussed at Town Meeting, 2025
- 2. Belvidere SB invited BPC to participate in additional research and meeting prep
- 3. Belvidere SB requested that LCPC research a Phase I Brownfield assessment
- 4. LCPC is working with Town on Village Trust Initiative grant
- 5. Belvidere SB is researching true costs of operation and tax rate implications
